TYPICAL SYSTEM DATA

PROCESSING

Mix ratio	Parts by weight	
RenGel [®] SV 410	100	
Ren [®] HY 2404	14	

Mix the two components thoroughly in the ratio indicated.

Apply in thin layers with a brush or spatula, wait until gelcoat has gelled, but ensure that it is still slightly tacky before proceeding.

Post-curing will improve final properties.

STORAGE

Provided that RenGel[®] SV 410 and Ren[®] HY 2404 are stored in a dry place in their original, properly closed containers at the storage temperatures mentioned in the MSDS they will have the shelf lives indicated on the labels. Partly emptied containers should be closed immediately after use.

The products should be handled when in the temperature range of 20 - 25°C.
