SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures General advice:

Unusual Fire and Explosion Hazards: Flash back possible over considerable distance. May form explosive mixtures in air. Exposure to combustion products may be a hazard to health. If the temperature rises there is danger of the vessels bursting due to the high vapor pressure. Vapours may form explosive mixtures with air.

5.3 Advice for firefighters

Fire Fighting Procedures: Collect contaminated fire extinguishing water separately. This must not be discharged into drains. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations. Contain fire water run-off if possible. Fire water run-off, if not contained, may cause environmental damage. Use water spray to cool fire exposed containers and fire affected zone until fire is out and danger of reignition has passed. SECTION 6: ACCIDENTAL RELEASE MEASURES
