The lightweight epoxy is an easy-to-handle material that exhibits high strength after curing. Epocast[®] 1617-A/B epoxy syntactic cures to an off-white color and is qualified to BMS 5-28, Type 17.

MIX RATIO:

To 100 parts by weight of Epocast[®] 1617-A resin, add 20 parts by weight of Epocast[®] 1617-B hardener. Mix both components thoroughly for several minutes to assure complete blending.

NOTE: Resin/filler separation may occur in Epocast® 1617-A resin. Remix before use.

CURE SCHEDULE:

7 days at 77°F (25°C) or gel at room temperature plus five hours at 125°F (52°C).

STORAGE/ sealed Syntactic epoxy resins and hardeners should be stored in a dry place in their original,

containers at temperatures from 60-90°F (16-32°C). Material temperatures should be

65°F (18°C) when mixing. After use, tightly reseal containers. Frozen materials should be stored at 0°F (-18°C) or colder and allowed to thaw at room temperature before use.

Under these conditions, syntactic epoxy resins and hardeners will remain useable for 6 months from date of shipping from Huntsman.
