**4.1 Description of first aid measures****General advice:**

### 5.1 Extinguishing media

**Suitable extinguishing media:** Water spray Alcohol-resistant foam Carbon dioxide (CO<sub>2</sub>)

### 5.2 Special hazards arising from the substance or mixture

**Hazardous combustion products:** Silicon oxides Formaldehyde Carbon oxides

**Unusual Fire and Explosion Hazards:** Flash back possible over considerable distance. Applying foam will release significant amounts of hydrogen gas that can be trapped under the foam blanket. Exposure to combustion products may be a hazard to health. Fire burns more vigorously than would be expected. Vapours may form explosive mixtures with air.

### 5.3 Advice for firefighters

**Fire Fighting Procedures:** Use water spray to cool fire exposed containers and fire affected zone until fire is out and danger of reignition has passed. Do not use a solid water stream as it may scatter and spread fire.

Use extinguishing measures that are appropriate to local circumstances and the surrounding environment. Use water spray to cool unopened containers. Collect contaminated fire extinguishing water separately. This must not be discharged into drains. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations. Do not allow extinguishing medium to contact container contents. Most fire extinguishing media will cause hydrogen evolution, and once the fire is put out, may accumulate in poorly ventilated or confined areas and result in flash fire or explosion if ignited. Remove undamaged containers from fire area if it is safe to do so. Evacuate area.

## SECTION 6: ACCIDENTAL RELEASE MEASURES

---

**6.1 Personal precautions, protective equipment and emergency procedures:** Remove all sources of ignition. Follow safe handling advice and personal protective equipment recommendations.

**6.2 Environmental precautions:** Discharge into the environment must be avoided. Prevent further leakage or spillage if safe to do so. Prevent spreading over a wide area (e.g. by containment or oil barriers). Retain and dispose of contaminated wash water. Local authorities should be advised if significant spillages cannot be contained.

**6.3 Methods and materials for containment and cleaning up:** Non-sparking tools should be used. Soak up with inert absorbent material. Suppress (knock down) gases/vapours/mists with a water spray jet. Clean up remaining materials from spill with suitable absorbant. Local or national regulations may apply to releases and disposal of this material, as well as those materials and items employed in the cleanup of releases. You will need to determine which regulations are applicable. For large spills, provide dyking or other appropriate containment to keep material from spreading. **7.1 Precautions for safe handling:** Keep container tightly closed. Keep away from water. Protect from moisture. Keep away from heat and sources of ignition. Take precautionary measures against static discharges. Take care to prevent spills, waste and minimize release to the environment. **7.2 Conditions for safe storage, including any incompatibilities:** Keep in properly labelled containers. Store in original container. Keep tightly closed. Keep in a cool, well-ventilated place. Store in accordance with the particular national regulations. Keep away from heat and sources of ignition. Product may evolve minute quantities of flammable hydrogen gas which can accumulate. Adequately ventilate to maintain vapors well below flammability limits and exposure guidelines. Do not repackage. Clogged container vents may increase pressure build up. Store in a closed container.

### 8.2 Exposure controls

When prolonged or frequently repeated contact may occur, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374) is recommended.
