## SECTION 4: FIRST AID MEASURES

---

### 4.1 Description of first aid measures

#### General advice:

### 5.1 Extinguishing media

### 5.2 Special hazards arising from the substance or mixture

**Hazardous combustion products:** Silicon oxides. Metal oxides. Carbon oxides. Formaldehyde.

**Unusual Fire and Explosion Hazards:** Applying foam will release significant amounts of hydrogen gas that can be trapped under the foam blanket.. Exposure to combustion products may be a hazard to health..

### 5.3 Advice for firefighters

**Recommended monitoring procedures**

Monitoring of the concentration of substances in the breathing zone of workers or in the general workplace may be required to confirm compliance with the Occupational Exposure Limits and the adequacy of exposure controls. ## 8.2 Exposure controls

**Engineering controls:** Use local exhaust ventilation, or other engineering controls to maintain airborne levels below exposure limit requirements or guidelines. If there are no applicable exposure limit requirements or guidelines, general ventilation should be sufficient for most operations. Local exhaust ventilation may be necessary for some operations.

### Individual protection measures

**Eye/face protection:** Use safety glasses (with side shields). Safety glasses (with side shields) should be consistent with EN 166 or equivalent.

#### Skin protection

**Hand protection:** Use gloves chemically resistant to this material when prolonged or frequently repeated contact could occur. **10.1 Reactivity:** Not classified as a reactivity hazard.
